

# Terms of Service

## Basic plan: 1-Year Membership + Certificate

### **I. Sign-up Process:**

Once payment has been submitted, you will immediately receive a *Membership receipt* from Paypal.com. *Secondly*, you will receive an email from Xtreme Ice Skating Corp asking for your full first name, last name, city/province, and country of residence. This information is important and will be required for registration and official filing (your last name is kept completely confidential). Expect an email 1-2 days after sign-up. *Thirdly*, once we receive your information, an email will be dispatched to you within 2-3 business days. This email will provide you with your login information, Certificate of Recognition, and guide to getting started. Total turn-around is approx. 3-5 business days (or less).

### **II. Membership Services:**

1. Monthly Newsletter: This newsletter will be a forum for Dan Perceval to talk about his thoughts and feelings in the sport of Xtreme Ice Skating. The Newsletter is emailed to our Members once a Month. It is posted on the Message Board for quick retrieval -- found on our *Newsletter* thread. It will also be emailed to every Member.

#### Contribute to our Newsletter:

1. Write a column for our Newsletter.
2. Submit advice.
3. Talk about new and/or emulated tricks.

2. Web Calendar: This service allows you to make plans or schedule unofficial events with other Xtreme Ice Skaters who are Members. You can create personalized events by posting times & places to meet.

3. E-certificate: An electronic or digital certificate will be emailed to you once we receive payment. Your e-certificate certifies you as an Xtreme Ice Skater. It also grants you right as a Member of the Xtreme Ice Skating Association.

4. Registration number: Your registration number will be listed on your e-certificate.

5. Registration listing on official website: Your registration will be listed on the Registration page. You hereby allow Xtreme Ice Skating Corp to publicly list your information on our website indefinitely. *Please note*: your last name will be kept private and will never be disclosed to any one, person, or business for any reason at any time. Your last name however will be shown on your e-certificate which only *you* can view.

6. Testings and competitions: As a Member, you may enter into Xtreme Ice Skating Testings and Competitions.

7. Action photo Contest: Every month, there will be a contest where winners will have the opportunity to have their Action photo linked on our homepage.

8. Wallpaper Contest: The *winner* of each Wallpaper contest will have their Wallpaper photo included on our upcoming wallpapers. (Wallpaper photos can be an action shot, image, or just plain self-portrait). When the contest takes place, you will be notified by email and/or Newsletter release. You can enter the contest by visiting our Contest page and filling out the appropriate form. 9. Access to Message Board: Xtreme Ice Skating Corp registers Members to our Message Board as Members sign-up for our services. Members receive a user name and password by email within 3-5 business days after submitting payment. Your user name and password will be the same for *all* Membership Services including our Message Board service. Additionally, you may change your user name and password at any time.

### **III. Usage rights:**

1. If you change your email address registered with us, you *must* let us know immediately! -- Otherwise we will not be able to contact you for contests or if there is a problem with your account.
2. This Membership provides you full access to *all* Membership Services.
3. A *breach* in this contract may result in loss of *any or all* Membership Services.
4. Xtreme Ice Skating Corp reserves the right to make changes, additions, or deletions to our Terms Of Service. You will be notified of any changes.
5. Xtreme Ice Skating Corp reserves the right to ban Members from Membership Services and/or the Xtreme Ice Skating Association.
6. Processing of your account usually takes 3-5 business days. All account information including your e-certificate will be emailed to you the same day.
7. Your user name and password are the same for all Membership Services.

### **IV. Pricing & Payments:**

- Prices are subject to change at any time.
- **Membership basic-plan: \$25 U.S. dollars / per year.**
- Duration of this Membership is one year. You may renew your Membership at any time before your account expires (expiration of your account is listed on the certificate).
- After one year, you have 30 days to reinstate your account by submitting payment at our Sign-up page.
- Payments must be made in full. Payments must be made through our business transaction account at Paypal.com.
- Failure to respond within 30 days of account expiration results in termination of your account. To continue your account, please visit our Sign-up page and fill out the appropriate form.

## **V. Message Board:**

1. No foul language or masked profanity.
2. Harassment of others will not be tolerated including obscene comments, direct attacks, innuendos, arrogance, and negative talk. Comments made against race, age, gender, and nationality will *not* be tolerated.
3. We reserve the right to restrict your Message board services if there's a breach of this contract.
4. *No* political, religious, or special interest comments allowed.
5. *Acceptable language*: English. We monitor these boards through English only.
6. Links to websites that reflect a conflict of interest will be deleted. Conflict of interest websites will be deleted.
7. Links to sites that contain porn, foul language, hate speech, demeaning undertone, inaccurate information, and/or offensive material will *not* be tolerated, and will be deleted.
8. Phrases or speech that's considered unacceptable speech will be deleted. Discussion of any said "unacceptable language" will *not* be tolerated under any circumstance. Said unacceptable language may or may not be stipulated in this contract.
